# Funding Education In NYS... Making Up Lost Aid

This article is designed to provide you with some additional information that we hope will help you to better understand how education is funded.

We have talked about the increasing cost of operating the school and, like our own personal budgets, there are not many places where things are going down. In order to keep pace we have to either cut, reduce, combine, share services or find other means or sources of revenues to make up for the loss of State Aid.

The state established “**Foundation Aid**” as a way to standardize funding and make it more predictable. In 2012-13 we will be entering the fourth year that we have been frozen at the same number. There was a plan to make adjustments to these aid figures but the economy and the State’s financial crisis put all of that on hold. On top of that, former Governor Patterson implemented a “Gap Elimination” adjustment to our aid which is basically a reduction. ECS lost \$424,825 in 2010-11, \$462,531 this year and we are projected to lose \$422,837 in 2012-13. These reductions have further complicated our ability to deal with rising costs.

**What is meant by “expense driven aid?”** There are primarily three areas of the budget that a District receives aid based on what they spend. Thus, if you spend more your aid will increase the following year but if you reduce then district revenues will be lower the following year. The areas covered include transportation, special education and BOCES services.

All school districts in our area are able to benefit greatly by buying or sharing services through BOCES due to the high level of aid they receive back. Most area districts receive 80-90% of their expenditures back the following year...ECS receives 36.6% of aid back on expenditures. This lower aid ratio is generally based on several factors that determine district wealth; the number of families that receive Free and Reduced Price Meals (22%), income of district residents and our property wealth.

ECS transportation aid is rather straight forward with a reimbursement rate of 40% (most area schools are 80-90%). Special education is much more complicated, based on the type of services, state and federal regulations and the individual needs of the students.

If a budget is defeated twice by voters, the district must adopt a contingent budget. This means that the 2012-13 tax levy cannot be increased by any amount ... so in effect, it would be a zero percent tax cap.

# School District Tax Rate Comparison With Common Towns

## ... *Ellicottville continues to benefit from growth*

The chart below provides you with a comparison of true value tax rates with neighboring school districts that have common towns with the Ellicottville School District. The table demonstrates how our District taxpayers are actually benefiting from the large tax base that has developed as a result of the growth of the ski industry and recreational interest in the Ellicottville area. The vast number of new homes, condos, business growth and overall property improvements has seen our tax base increase from \$303,090,477 in 2002-03 to \$788,228,948 (2011-12). This change represents a 260 % increase in the last nine years! While that growth has now settled down, the resulting tax base provides our district with one of the lowest tax rates in this part of New York State!

If you look at the true value tax rates from 2004-12, you will see that, with the exception of one year, the tax rates have steadily decreased from \$13.36 per \$1,000 of assessed property in 2004 to \$7.39 in 2012. This represents a 44% decrease!

The comparison chart shows what school taxes would be like in a neighboring school district. For purposes of comparison we are using a home assessed at \$100,000. The rates are based on \$1,000 of assessed property so if you multiply the true value tax rate x 100 you will see how school taxes differ in the various school districts.

# Apply Now For **SPRING SCHOLARSHIPS**

Each year several local scholarships and awards are given at graduation ceremonies. Ellicottville Central School is truly fortunate and grateful to have so many families, organizations, and businesses generously offer these funds to graduating students. Many of the scholarship / award recipients are chosen by the family, organization or business through a selection / application process that they have developed. Seniors should watch for information related to these scholarships and awards.

At the same time, some of the families, organizations and businesses that offer scholarships and awards have elected to use an application process through ECS. Below is a list of the scholarships and awards that students need to apply for through the guidance office. Please carefully read the requirements for each award to be sure that you qualify based on the criteria listed.

**Please submit the necessary information to the Guidance Office by May 14<sup>th</sup>.**

**HOLIDAY VALLEY SCHOLARSHIP** - Seniors are asked to submit an essay on community service that they have been involved in and explain why community service is important. Three scholarships will be given: two at \$2,000 each and one for \$1,000.

**HUGHEY MEMORIAL SCHOLARSHIP** - Seniors who plan to attend college and major in Science or Education are encouraged to apply for this \$1,000 scholarship. Please submit an essay with information about yourself and your future plans.

**DANIEL SIRIANNI MEMORIAL SCHOLARSHIP** - Seniors who plan to attend college and major in Business or Education are encouraged to apply for this \$1,000 scholarship. Please submit an essay with information about yourself and your future plans.

**JOSEPH F. WARD MEMORIAL SCHOLARSHIP** - Seniors who plan to attend college and major in an Agricultural or Environmental related field are encouraged to apply for this \$1,000 scholarship. Please submit an essay describing yourself, your intended major, and your future career plans.

**ELLCOTTVILLE ROTARY CLUB AWARD** - Seniors who have participated in community service, have a minimum B average, participate in extra-curricular activities, demonstrate leadership skills and plan to attend college are eligible. Please submit an essay on your activities and accomplishments to be considered for this \$500 award.

**ELLCOTTVILLE TEACHER'S ASSOCIATION AWARD** - Seniors who plan to attend college and major in education will be considered for this \$500 award. An application is not required. The ETA will meet to determine the 4 award winners. Additional criteria may also be used in determining the winners.

**LELAND ARTHUR EASTMAN MEMORIAL AWARD** - Seniors who plan to pursue a career in Photography, history or journalism are encouraged to apply for this \$400 award. Please submit an essay with information about yourself and your future plans.

Describe and explain what characteristics and qualities you possess that makes you deserving of this scholarship. You should also include in your essay any situation where you have overcome an obstacle or met a challenge in your life. Please include a time when you made an impact on someone's life. An additional application is required for this scholarship; please stop in the Guidance Office to pick one up.

**ECS ALUMNI ASSOCIATION AWARD** - Seniors who are academically motivated and plan to attend college are invited to apply for this \$300 scholarship. Additional criteria are: Demonstrated Leadership, Community and School

involvement and good character. Please submit an essay describing your qualifications for this scholarship. One male and one female will be selected for this award.

**CATTARAUGUS COUNTY BANK AWARD** - Seniors who plan to attend college and major in business are eligible to apply for this \$200 award. Please submit an essay indicating your future plans in relation to business.






